- ( ) **Executive – \$50 annual dues:** open to active, certified Jail Administrators only.
- ( ) **Professional - \$25 annual dues:** open to sworn, certified, and civilian staff actively employed with any city, county, regional, or state detention facility, work camp, or prison.
- ( ) **Honorary - \$25 annual dues:** open to active Sheriff's, Chiefs of Police, County or City Administrators, and Agency Heads of law enforcement related organizations who support the association.
- ( ) **Life - Dues waived:** retired members of the South Carolina Jail Administrators' Association or persons so designated, who have rendered extraordinary service to the detention profession or SCJAA and who have been elected to Life Membership by the Board of Directors.
- ( ) **Associate - \$15 annual dues:** open to persons who are not otherwise eligible for membership; including students and members of the general public, who support the mission and goals of the South Carolina Jail Administrators' Association and who promote professionalism in the field of detention services.
- ( ) **Corporate - \$100 annual dues:** open to businesses, corporate entities or other organizations that support the SCJAA and who promote professionalism in the field of detention services.
- ( ) **Facility Membership – \$100 annual dues:** a special category open to all detention centers that desire to support the goals and mission of the association. Includes a special annual conference discount option.
